**Examination and Study Regulations for the Bachelor's Degree Programme
"Sustainable Development Studies" at the Georg-August-University of Göttingen**

§ 1 Scope

- (1) The provisions of the "General Examination Regulations for Bachelor's and Master's Degree Programmes and Other Degree Programmes at the University of Göttingen" (APO) and the "Framework Examination and Study Regulations for Bachelor's Degree Programmes in the Faculty of Business and Economics" (RPO-BA), as amended, apply to the Bachelor's degree programme in Sustainable Development Studies at the University of Göttingen.
- (2) These regulations govern the further provisions for the completion of the bachelor's degree programme.

§ 2 Qualification Objectives

¹In addition to the general objectives of the bachelor's degree programme defined in the RPO-BA, graduates of the Bachelor's degree programme in Sustainable Development Studies should have extensive specialist knowledge in development studies, methodological knowledge in economics and social sciences, language skills in English and intercultural skills for working in or with the Global South, taking into account the requirements and changes in the professional world. ²Graduates are familiar with the latest developments in development studies and have the ability to map and analyse complex problems of the Global South in their

relevant economic, political and social context.³They are able to take into account the interdependencies within and between the subject areas and additionally include social consequences in the decision-making process, thereby supporting interdisciplinary thinking and responsible action.⁴They acquire the ability to carry out independent scientific work, to critically categorise scientific findings and to communicate and cooperate within science and with various stakeholders in society.⁵By focussing on the aspect of sustainability, graduates are familiar with the economic, ecological and social dimensions of sustainability and are thus supported in the development and application of scenarios for sustainable action as well as in their development into responsible and critically thinking people.⁶In addition, diversity-oriented perspectives are incorporated into the subject content, which contributes to the ability to reflect on stereotypes and prejudices and to identify discrimination.⁷To develop an individual profile, in addition to a sound education in development studies, students also acquire specialised knowledge through a suitable subject-specific or regional focus in the areas of development economics, globalisation, sustainability or regional studies.⁸The programme structure also ensures the acquisition of relevant digital skills for study, research, career and social participation in a manner appropriate to the subject.⁹During a mandatory study abroad, students are taught specialist knowledge from a different perspective and have the opportunity to gain experience in countries of the Global South, acquire intercultural skills in a development context and expand their language skills.¹⁰The international orientation of the degree programme prepares students for an international working environment in development cooperation or in international organisations, associations, non-governmental organisations, internationally oriented companies and research institutions, which opens up excellent career opportunities.¹¹In addition, the programme forms the basis for a consecutive master's degree.

§ 3 Content Structure of the Bachelor's Degree Programme and Credit Requirements

(1) ¹The 180 C required to pass the bachelor's examination are acquired through compulsory, compulsory elective and elective modules as well as the bachelor's thesis.²In addition to the specialised studies, the degree programme also includes a specialisation and elective area for individual study design, which may also include the teaching of key competencies.

(2) The degree programme is divided into a two-semester first part of studies (orientation phase), in which 60 C must be acquired through compulsory modules, and a second stage of studies (3rd to 6th semester), in which 120 C must be acquired through compulsory, compulsory elective and elective modules as well as the bachelor's thesis.

(3) ¹The number, type and scope of the modules to be successfully completed are regulated in the module overview (Appendix I).²A recommendation for the appropriate structure of the

degree programme can be found in the attached curricula (Appendix II). ³The module catalogue is published separately; it is an integral part of these regulations insofar as the modules are listed in the module overview (Appendix I).

§ 4 First Part of Studies (Orientation Phase)

(1) ¹In the orientation phase, students should acquire knowledge of the fundamental problems and approaches of development studies as well as some important neighbouring disciplines and they should acquire basic knowledge in the field of ethnology and the economic fields of microeconomics and macroeconomics. ²At the same time, students will acquire knowledge of economic methods. ³The modules to be completed in the orientation phase can be found in the module catalogue and are listed in Appendix I. ⁴A preparatory course in Sustainable Development Studies is offered at the beginning of the programme and students are strongly recommended to attend this course. ⁵In addition, a preparatory course in mathematics is offered, which enables students to refresh their knowledge of mathematics before starting the degree programme.

- (2) All courses in the orientation phase with the code B.WIWI-OPH are offered every semester.
- (3) There are no module-specific admission prerequisites and no admission restrictions for the courses of the orientation phase.
- (4) The diagram in Appendix II provides a recommendation for an appropriate structure of the orientation phase.

§ 5 Second Stage of Studies (In-Depth and Specialisation Studies)

(1) The in-depth and specialisation studies serve to complete the basic education as well as to deepen the knowledge through a suitable professional or regional focus and thus creates the possibility of specialisation according to individual ideas and career goals or for continuing education.

(2) ¹The bachelor's degree programme includes a one-semester study period at a foreign University in a country of the Global South in accordance with the DAC list of the OECD as amended. ²During the period of study abroad, students should complete coursework equivalent to 30 C, but at least 18 C must be completed. ³The coursework completed should be related to sustainable development studies, ideally to the chosen specialisation. ⁴The coursework must essentially correspond to the requirements of a bachelor's degree programme and may not already be the subject of a module examination already taken or to be taken as part of this degree programme before the start of the stay abroad. ⁵The

Examination Board shall decide on the recognition of the coursework completed at the foreign University.⁶This should be bindingly stipulated prior to the stay abroad by concluding a learning agreement.⁷Failed examinations during the one-semester study programme at a foreign university can be retaken at the University of Göttingen.⁸As an alternative to the semester abroad at a University in the Global South according to sentence 1, the module B.WIWI.SDS.0005 "Internship in the Global South" or the module B.WIWI.SDS.0006 "Field Research in the Global South" totalling 18 C can be completed.

(3) The 120 C to be completed in the second stage of the programme are made up as follows:

- 36 C in the advanced study section,
- 48 C in the area of specialisation,
- 24 C in the elective area and
- 12 C in the bachelor's thesis.

The bachelor's thesis is written in the chosen specialisation.

(4) The modules that can be taken in the individual study sections and areas can be found in the module catalogue and are shown in Appendix I.

(5) The diagram in Appendix II provides a schematic overview of the structure of the second stage of the programme and contains a suggested timetable.

§ 6 Specialisation Area

(1) ¹Students on the Bachelor's degree programme in Sustainable Development Studies must choose a specialisation area during the second stage of their studies. ²Recommendations regarding the selection of modules suitable for the desired profile will be given during the study advisory and information events organised by the faculty.

(2) ¹Students must choose a specialisation during the course of their studies, which is shown on the Bachelor's certificate. ²The following specialisations can be chosen:

- Development Economics
- Globalisation
- Sustainability
- Regional Studies

(3) ¹In order to be awarded a specialisation, students must successfully complete modules totalling at least 48 C that can be credited to the respective specialisation. ²Crediting of the bachelor's thesis is not possible. ³The modules to be allocated to the specialisations can be found in the digital module directory and are listed in Appendix I.

(4) ¹Students who intend to complete the bachelor's degree programme as a basis for a subsequent master's degree programme are recommended to acquire scientific knowledge and methods through a suitable selection of modules. ²Students who are aiming for the consecutive Master's degree programme in Development Economics are recommended to specialise in Development Economics. ³Students wishing to pursue the consecutive Master's degree programme in International Economics are recommended to specialise in Globalisation. ⁴Students who are aiming for the consecutive Master's degree programme "Agricultural Sciences" or "Sustainable International Agriculture" are recommended to specialise in "Sustainability". ⁵Students who are aiming for the consecutive Master's degree programme "Modern Indian Studies" or "Ethnology" are recommended to specialise in "Regional Studies" with the corresponding module selection. ⁶Students who wish to switch to professional practice after their bachelor's degree programme are recommended to acquire both subject-specific and interdisciplinary professional knowledge and skills. ⁷The acquisition of subject-specific professional qualification knowledge can be achieved in particular by specialising in a subject (cf. section 2) and by working on a topic that directly qualifies for a profession as part of the bachelor's thesis.

§ 7 Entry into Force; Transitional Provisions

(1) These regulations shall enter into force on 01.10.2022 following their publication in the Official Announcements I of the Georg-August-University of Göttingen.

(2) ¹Students who began their studies before an amendment to these Examination and Study Regulations came into force and were continuously enrolled on this degree programme will be examined in accordance with the Examination and Study Regulations in the version valid before the amendment came into force. ²In the case of examinations still to be taken, this does not apply to the module overview and module descriptions, unless the protection of a student's legitimate expectations requires a different decision by the Examination Board. ³A deviating decision is possible in particular in cases in which an examination can be repeated or a compulsory or required compulsory elective module has been significantly changed or cancelled. ⁴The Examination Board may issue general regulations in this regard. ⁵Examinations in accordance with a version of these Examination and Study Regulations that was valid before an amendment came into force shall be taken for the last time in the sixth semester following the amendment coming into force. ⁶Upon application, students pursuant to sentence 1 shall be examined in accordance with the provisions of the amended regulations.

d. Language course modules totalling a maximum of 12 C can be selected. Modules in German, English and the student's native language cannot be considered. e. Modules from the following list of module groups and modules from the University of Göttingen's central key competence programme, provided that the admission requirements specified there are met. Modules with the identifier SK.AS will only be considered up to a maximum total of 7 C; modules will not be considered on a pro rata basis; a module that exceeds the maximum total of 7 C can only be considered as a voluntary additional examination.

fa. an application by the student, which must be submitted to the Dean of Studies of the Faculty of Economic Science before the alternative module is taken;


fb. the approval of the Dean of Studies of the faculty or teaching unit offering the alternative module.

The decision on the approval of the application is made by the Dean of Studies of the Faculty of Economic Science. Before making the decision, the Dean of Studies will obtain an opinion on the appropriateness of the module replacement from lecturers of the degree programme in which the student is enrolled. The application can be rejected without stating reasons; the student making the application has no legal claim. The consideration of a module that has already been completed as an alternative module is excluded.

4 Bachelor's Thesis

The successful completion of the bachelor's thesis earns 12 C. The bachelor's thesis is written in the chosen specialisation. Those responsible for the specialisation must confirm in advance that the bachelor's thesis topic matches the specialisation.
